- The Citizen's Charter is written in English, is posted as information billboards in all service offices of San Jose Del Monte City Water District that deliver frontline services.
- The Citizen's Charter is positioned at the main entrance of the office and at the most conspicuous of its extension office in Francisco Homes, and its collection office in Sarmiento Homes, all located within the service area of San Jose Del Monte City Water District in the City of San Jose Del Monte, Bulacan.
- The Citizen's Charter is also published in a brochure-type information material and distributed to the customers of San Jose Water and is uploaded in the agency's website and accessible to the public.
- The Citizen's Charter was published on July 10, 2009 and has been thrice reviewed and revised, the latest of which is December 2013 as required under Section 4, Rule IV of the IRR which states that the office or agency shall review the Citizen's Charter whenever necessary, but not less than once every two years.
- 6. The Citizen's Charter already shows the improvements that resulted from the process review of frontline service delivery.

This certification is being issued to attest to the accuracy of all the foregoing based on available records and information that can be verified.
